-in the late Seventies, Mr. Pheonix installed a water and sewer line from 5216-50 Avenue to his lot at 5228-50 Avenue-between 150-200 ft

-a ¾ inch water line was installed that services two properties- 5228-50 Avenue and 5224-50 Avenue

- -sewer line is quite shallow-can probably be lowered
- -5220-50 Avenue is for sale-concerned if someone develops on the property, the ¾ inch line may not be able to handle another service-if they tie into the sewer line, would like to recover some of his costs that he incurred in the 70's similar to what is being done with Whitetail Crossing
- -cost in 70's about \$8,000 which included the work on his lot that was required
