-at this time they would like to know the type of service that we would like

a. keep with the current provider

b. have East Central Health provide the service.

-no information if we would be able to get service from Vegreville which has a quicker response time

-Lamont County will probably agree to maintain the existing service -unsure of the role of fire departments in the provision of emergency medical service

08/144 Saric: that the Town notify the East Central Health Board that they wish to continue with the current ambulance service provider but express a desire that service should be the most efficient and with the quickest response time possible, with existing service levels still being met.
