Business (a) Unsightly Order, 5231-53 Avenue

An unsightly order was issued against 5231-53 Avenue under section 546 of the MGA. Under this section, an appeal is made directly to Council. The owner was to demolish the buildings and level the property by June 22.



An appeal of the order was received from the Bank of Nova Scotia who has initiated foreclosure proceedings.

- -they have a preservation order which allows them to secure the property
- -they expect the foreclosure to take approximately 2 months
- -they would like an extension on the demolish order so that they can sell the property
