(b) Drainage Issue-4929-4933-52 Avenue

A letter from the owner of 4929 & 4933-52 Avenue regarding drainage on the property was presented.

- -there is a current drainage ditch between the two properties
- -the owner wishes to fill in the ditch and landscape the property
- -the ditch drains all the water from the backalley
- -there is a ditch to the West of 4933 but we do not believe that it drains into the storm sewer
- -the Town needs to start dealing with these type of drainage issues



-given the cost and work that needs to be done, the Town will look at completing the work next year

-the owner shall be required to provide some lot grades showing how the water will drain from their property and the lots need to be properly landscaped.

Discussion also took place regarding drainage behind the national hall. A swale needs to be made to allow for proper water drainage.

(h) Pole Relocation

It has been discovered that there is an issue with regards to the back alleys in the block between 50 and 51 Avenue, East of Main Street. The property line of 4927-51 Avenue is actually in the back alley. There are a couple of power



poles that are located further from the property lines than normally placed and may have to be moved.

- -poles are normally placed 0.6m from the property line
- -the poles are up to 0.6 m further out
- -Atco Electric provided an estimate of \$16,505 to move the poles
- -under the franchise agreement, the cost is to either be paid by the Town or by a rider on electrical bills
- -another method of cost recovery is to increase the franchise fee-a fee increase of 3% would be required-the current fee is 2%

- -can use 2012 grant money for other projects or carry over till next year
- -there are some sidewalk's that can be worked on
