(e)Fire Commissioner Office - Uniforms

The CAO contacted the fire Commissioners Office. The field officers will still wear uniforms. It is in the office that uniforms will not have to be worn.

It is the 40th Anniversary of the Vegreville Pysanka festival and they are celebrating with a music festival.

(g)Road Concerns – 52 Avenue

A letter was received from residents expressing concerns about the amount of dust on the westerly end of 52 Avenue.

- -Public Works is applying Calcium Chloride on the road to keep the dust down.
- -Concerns were brought forward about the speed people are travelling on that road.

(h) Drainage Concerns – Father Filas Manor

A letter was received about a drainage problem on the north east portion of Father Filas Manor.

-the area remains wet for most of the summer and they are unable to maintain it.

The Town foreman will meet with the manager of the lodge and look at the issue.

-The CAO will send a letter to the lodge stating that the issue is being dealt with.

Charlie Gargus pointed that she he received a call from the Chicken Coop expressing concerns about a drainage issue by her store.

-Public Works will take a look at it.

Irene Talaga pointed out that the culvert by the Stawnichy Park is plugged.

There is drainage issues at the school.

-Public Works will unplug the culvert and will be doing regular maintenance on the culverts.

(i)Tender Policy -

The CAO contacted Lamont County and their policy is that Council makes the decisions on tenders.

- -A reserve price is usually set for all tenders.
- -they do reserve the right to not accept any or highest tender
- Talaga that policy 12-06 Asset Disposal be accepted.

(k) Old Hospital Water Meter

The Town is in the process of replacing the old meter with a new radio meter that can be read remotely. New developments are required to pay for a meter. The cost of this meter is \$1,100 plus the cost to install.

(l) Grass Cutting – Whitetail Crossing

Only 12 responses were received from landowners at Whitetail Crossing wanting the Town to maintain their properties.

Discussion took place as to whether the Town should spray the vacant lots.

-The CAO will contact the contractor and see if he is interested in cutting grass.

(m) Sewer Lagoon

Jaime Burghardt inquired if the windmills at the lagoon were working as the smell from the lagoons is very strong.

- -it appears that they are working but Public Works will double check
- -Public Works will look at options for having the sludge from the lagoons cleaned.

(n) Drainage at Greenhouse

Public Works has had more gravel hauled in by the greenhouse as they is a lot of standing water.

- -they are going to obtain a packer to tamp the road to even out the potholes
- -Mike Hrycyk from St Michael would like the opportunity to provide a quote for gravel

(o) Interagency Meetings

Discussion took place about having meetings with all the organizations in Town as a group to help with planning events in Town.

-Colin Zyla will talk to Susan Campbell about the possibility of setting up a meeting.

(p)Purple Martin House

It was pointed out it is a myth that Purple Martin eat mosquitos. Barn swallows are a better option.
