(b)Recycle Yard

With the changeover in garbage collection and taking of garden debris, there is a lot more interest in the recycle yard.

-Currently during the summer the yard is open on the second Saturday of the month from $8:00~\mathrm{AM}-12:00~\mathrm{p.m.}$ During the winter only two hours from $10:00~\mathrm{am}$ to $12:00~\mathrm{p.m.}$

(c)4707 - 49 Street

There was a drainage ditch on the east side of 4915 - 51 Avenue (between the trailer and telus) The drainage ditch was located at 4915 - 51 Avenue-there is no easement for the ditch registered at land titles.

The owner approached the Town in the spring to talk about the ditch. He wished to fill in this area and sell the property. In order to allow for proper drainage, we put in a culvert. The owner wants to build up part of the property where the culvert is to the height of the lot so that he can sell it.

Discussion took place about how the lot next door is going to drain and if the town is obligated to fill in the whole area.

The CAO, Public Works foreman and the owner of the property will meet at the property and will come to a mutual decision of what is going to get done.

(e)Garbage Collection

Discussion took about recycling at some of the Commercial locations.

The CAO spoke to Stawnichys about their bins being outside still. Their plan was for the bins to be put in the garage but they are not able to due to health concerns. The town is looking at compactor bins that may solve some of the problems.

In past if residents are going on vacation for extended periods of time they were able to terminate garbage service till they returned.
