## (a) Lisa Euchuk – Canada Day

#### (b) Utility Bills – 5304 – 51 Avenue

The CAO presented information regarding utility bills for 5304 – 51 Avenue

On September 3, 2015, \$ 1663.96 (including penalties of \$ 604.64) was transferred to taxes for utilities covering September 2014 to July 2015. During this time the town did receive some payments.

On December 31, 2015 \$ 419.54 (including penalties of \$ 30.59) was transferred to taxes covering August 2015 to November 2015.

There were also outstanding utilities in the amount of \$ 1012 (including penalties of \$ 234.05) from December 2015 to October 2016.

The Town should have been more diligent in transferring the amount to taxes. The CAO recommended cancelling the penalties that were applied.

Administration has reviewed how surrounding communities deal with renters.

As of January 1, 2017, utility bills will only be sent to the owners of the property.

<u>Talaga</u> that for Plan 7321BW, Block 21, Lots 1 and 2 taxes in the amount of \$ 635.23 and utility penalties of \$ 234.05 be cancelled.

#### (c)Lamont County – InterMunicipal Collaboration Grant

A letter was received from Lamont County approaching towns and villages seeking support to jointly apply for an intermunicipal collaboration grant to fund the exploration into the creation of a joint inter-municipal water/wastewater utility

to assume management and operations of water and wastewater utilities within the proposed member municipalities.
