#### (c)Lot Sales Agreement

### (d) Lamont County Rural Transportation Coalition

A request was received from the Lamont County Rural Transportation Coalition asking for support to ask Alberta Transportation to conduct a new study to address barriers to access public transportation in rural Alberta communities . They believe that the study does not recognize smaller rural municipalities with no access to Public Transportation.

<u>Talaga</u> that a letter be sent to the Alberta Transportation Ministry expressing the need for provincial strategies and programs that address rural communities needs.

# (e) Food Trucks

The CAO brought forward information on fees neighboring communities charge for hawker/peddler licenses.

The amount of door to door salesman has been reduced as the province has banned door to door sales of energy contracts, furnaces, water heaters etc.

Discussion took place and it was decided to continue charging \$ 20 for hawker/peddler license.

#### (f) Alberta Weekly Newspaper Association

A request was received from the Alberta Weekly Newspaper Association for a letter of support for the Alberta Government to provide funding to digitize Alberta historic newspapers
