

**Town of Mundare**

**Bylaw 794/08**

The Council of the Town of Mundare properly assembled enacts as follows:

1. This bylaw is known as the “2008 Mill Rate Bylaw”.
2. Detailed estimates of the town revenue and expenditures were adopted at the council meeting held June 3, 2007.
3. The estimated municipal expenditures and transfers set out in the budget for 2008 total \$3,455,600.
4. The estimated municipal revenues and transfers from all sources other than taxation is estimated at \$2,730,203 and the balance of \$725,500 is to be raised by general municipal taxation.
5. The 2008 requisitions are:

Alberta School foundation Fund	
Residential	\$94,780
Non Residential	\$20,538
Senior Foundation	\$13,319

6. Lands annexed by the Town are subject to the Lamont County mill rate for municipal purposes as agreed to between the Town and the landowners of the annexed lands.
7. Despite Section 6, tax annexed lands may be taxed at Town Municipal mill rates if the Town municipal mill rate is less than the Lamont County municipal mill rate.
8. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town.
