There may only be 1-2 staff in the Mundare Youth Centre at any given time. Any minors age 7 and under must be supervised by an adult. Minors age 8 and older may attend without an adult if they have submitted a fully completed form signed by their legal guardian. They will be treated as adults and will be expected to participate appropriately. **There will be zero tolerance for disrespecting of people and property.** Everyone will be allowed to come and go freely as this is a drop in program.
